# **NOMINATING COMMITTEE PROCEDURES:**

The Council Member Handbook does not contain a written procedure specifically addressing the succession of officers. In accordance with the Florida Administrative Code, section 29H-1.005(4), "The officers shall be elected at the annual meeting of the Council and shall hold office for one (1) year or until their respective successors are elected and qualified. The Council shall utilize a Nominating Committee, chosen by the Chair, for nominating the annual slate of officers. Any vacancy in office shall be filled by the Council at its next regular meeting; the person so elected shall serve until a successor is elected and duly qualified." Current sitting Nominating Committee members are not eligible to be nominated for Office.

It is the Tampa Bay Regional Planning Council's goal to have a Nominating Committee in place by the November Council meeting. When selecting the slare of officers, the Nominating Committee shall consider the member's tenure, committee participation, and commitment/support of the Council's Mission. Consideration shall be given to the county not represented as an office holder. The Nominating Committee shall offer the slare of officers at the Annual Meeting.

A vacancy occurring during the year shall prompt the Chair to select a Nominating Committee to replace the vacant office holder. The Nominating Committee shall present a nomination for Secretary/Treasurer at the next scheduled Council meeting. The remaining officers shall be moved up to the next position as the case may be.
